- board understood "to be developed" meant new construction
- go through the whole process to change the ordinance

- adding verbiage or changing the word developed

- request from the attorney for the correct language usage
- we want residents to be allowed to add on to their dwellings

#### Mayor Pro Tem Arzabal

- recommends that they agree on what they want before it goes to the attorney

#### Mayor Barraza

- amend verbiage "to be developed"

#### Commissioner Nevarez

- non-conforming lots would not allow construction; hands would be tied

#### Mayor Barraza

- would need to meet the requirements
- that is what we are trying to correct with this ordinance

- asked if add on building permits would be allowed to non-conforming lots if requirements are met

- will look at development standards
- reiterated looking at the verbiage

- asked if there is an established resident, requesting a permit that will change the footprint but meets the requirements, it will be allowed

- we are trying to look at that in order to send the correct message
- consider the population density as well

## **Open Public Hearing at 6:31 p.m.**

Ms. Krueger stated she was speaking about alternations made since 2000. She was addressing context exploration which takes a lot of time and research. She feels research was not done to do a complete context exploration in Mr. Taylor's case. The resolution states that the ordinance does not allow changes to the historical preservation to this significate structure. She remembers the board discussing where or not you could make a change to the exterior of a significate structure. She feels that has been done in the Town of Mesilla as long as the plan meets the code and what CID requires.

b) For Approval/Disapproval: on PZHAC Case 061110 an appeal submitted by Susan Krueger -2341 Calle de Arroyo, submitted by Michael R. Taylor; a request for a zoning permit to enclose the front porch on a dwelling at this address. Zoned: Historic Commercial (HC). \*\*After approval/disapproval of the above appeal, a resolution stating the board's decision and reasoning shall be approved at the next Board of Trustee meeting\*\*

Mayor Pro Tem Arzabal requested suspending the rules

Mayor Barraza explained the process that will be followed. She asked Mayor Pro Tem Arzabal if he would like to hear the appeal before suspending the rules.

Mayor Pro Tem Arzabal responded they can hear the appeal first.

Ms. Krueger stated she is talking about context and whether ordinance 18.33 applies to Mr. Taylor's request to enclose the side porch. Board comments were that they did not apply, and that ordinance would be violated if the case were approved. She believes the ordinance provides for changing the exterior of a structure such as in the definition of brief rehabilitation. Mr. Taylor was not given the opportunity to document changes made to that residence. Neither the Zoning ordinance nor the Iguado Plan prohibits continuous alternations to a significant structure; plans will need to meet the code and CID requirements. Reiterated she was addressing alterations made to La Posta since 2000. Changes were done to open another entrance to La Posta to provide efficient contemporary use. The passageway next to the Fountain Theatre was closed for good reason. The findings given to deny Mr. Taylor's request needs further scrutiny. She respects the work done by the Planning and Zoning and the Board of Trustees. She feels the board's decision to deny Mr. Taylor's case should be reversed; case needs further research with regards to the context.

Commissioner Salas stated the Planning and Zoning is following the ordinance and any deviation would need to come from the Board of Trustees. He believes Mr. Taylor would do it in the most authentic way. This is not rehab or adding square footage. As a community we need to see how far we want to go with these cases and if it will benefit the town. La Posta's alternations do benefit the town. He does not believe Mr. Taylor would reverse this; it would be permanent.

Mayor Barraza stated vote needs to include the reason for the board's vote.

Mayor Pro Tem Arzabal stated he understands Ms. Krueger is appealing this case for Mr. Taylor.

Mayor Barraza responded any interested party can do an appeal.

Trustee Johnson-Burick stated will not change her vote for denying the case. She feels the porch will change the buildings characteristic.

Mayor Pro Tem Arzabal called for the question.

Trustee Garcia Yes – we need to follow the ordinance and supports Planning and Zoning Trustee Johnson-Burick Yes – supports Planning and Zoning. Alterations would impede on the historical part of this residence. It will be partially visible.

Mayor Barraza stated a resolution will be brought forward at the next meeting.

Mr. McGillivray responded he believes it is every 10 years.

#### **12. BOARD OF TRUSTEE/STAFF COMMENTS**

Fire Chief Hoban stated the Fire Protection Grant application was denied. We had a trailer donated to burn for training. The state has cancelled burns in the fall.

Mr. McGillivray stated trail is almost completed, roadwork projects have been completed.

Ms. Stoehner-Hernandez stated there are 14 CARE Act applications and 4 have been sent to DFA.

Marshal Lerma stated he had officers exposed to COVID; tests were negative.

Trustee Garcia asked that everyone be safe and get tested.

Trustee Caro sent prayers and condolence to everyone affected by COVID. He asked if there is anything planned for Veteran's Day.

Mayor Barraza responded nothing is planned for Veteran's Day.

Mayor Pro Tem Arzabal asked everyone to pray as the school kids are suffering during this pandemic. He asked if masks can be made mandatory throughout the town. People from Texas are coming to the town.

Marshal Lerma stated we can take enforcement action ourselves. There is only 1 officer on duty on the weekends. People need to call us so we can do what we can.

Mayor Pro Tem Arzabal stated the officers need to go to the Bean and Shorty's on the weekends.

Mayor Barraza stated the mandate is there. She will meet with Marshal Lerma to discuss this further.

Trustee Johnson-Burick thanked Mr. & Mrs. Saenz for bringing forth their concerns. She asked is there anything we can do to help the students.

Trustee Garcia stated we need to report positive tests.


