#### **Project update:**

Calle del Norte Trail Phase II – Project on-hold pending NMDOT and IBWC approval. Project is still anticipated to bid in January.

**SCADA** – Grant agreement received and returned. NMED review of revised proposal from BHI is underway. Request for part time construction observation and permission for the Town to self-perform construction observations submitted to NMED.

**Mesilla Water System Booster Replacement** – Project drawings are 60% complete. Project on-hold pending approval from BLM. BLM indicated they would not review the permit application until spring of 2022. NMED has been notified.

**Mesilla Streetlight Improvements** – Molzen Corbin has been contracted to provide engineering services for this project. Sixty percent drawings are anticipated to be complete by the end of January.

**Calle de Picacho:** Preliminary design and project scoping is underway. Anticipate receiving proposal from MC for design services by mid-February.

**Plaza Sidewalk Refurbishment** - Grant agreement received and returned. Waiting for final signatures and copy of executed agreement. No activity.

**Guadalupe House Sidewalk** – Project is considered complete.

**University Waterline Improvements** – Review of proposal for professional services from BHI is underway.
