Trustee Cadena stated she appreciated the Public Input.

Trustee Garcia thanked Ms. Bush for reviewing the budget process with the trustees and asked her to look into the \$110,000 before it is lost. She wants legal opinion to ensure the trustees are correctly following the appeal process.

Ms. Bush responded she is looking into it.

Mayor Pro Tem Johnson-Burick stated it was a wonderful opportunity to represent Mesilla during the reception for the Secretary of Interior. She thanked Senator Hamlen for the funding she provided the town.

Trustee Merrick thanked Ms. Bush for reviewing the budget process. Stated it would help if Mr. Cervantes would have attended this meeting to answer questions that have come up such as when Trustee Garcia asked if it was 2/3 and Ms. Maya said motion does pass.

Mayor Barraza stated Mr. Cervantes will not be available until April; he is not required to attend every meeting. She will call a Special Meeting if necessary. Encouraged the trustees to bring forth questions they may have during the MOLI Training. Chapter 18 reviews the appeal process. There will be a Special Meeting for a Liquor License on Tuesday, April 5<sup>th</sup> at 3:00 p.m. The attendees have been registered for the MOLI Training and she passed out hotel reservations confirmations. The auditors will review the FY21 Audit Report, which is being provided to you for your review, at our next BOT meeting.

Trustee Garcia asked if the April 5<sup>th</sup> meeting could be done by phone or zoom.

Mayor Barraza responded we are currently not set up for that; Mr. McGillivray is currently in the process of updating our system. We can a teleconference if she would like to call in.

Trustee Garcia asked if packets can be made available by Wednesday or Thursday. Ms. Bush responded that is her goal.

Mayor Barraza stated we are working with Planning and Zoning and the Architectural Style Committee to get information so that the packets are out by Wednesdays.

Trustee Cadena stated she would like to ensure that packets are complete when they are sent out; this is a process that needs to be worked on. She wants to see that citizens feel they are being treated fairly and equally. Trustees need to review all pertinent information and material. We need time to do research, have dialog with citizens, staff and mayor. She recommends staggering the meetings. She wants to come with full knowledge and understanding of what needs to be voted on. She wants to become familiar with the code book; put things in priority.

Mayor Barraza stated we are trying to streamline the process. It is currently taking to long to process applications. There are only limited projects that can be administrative approved. Mr. Padilla is ensuring that all applications have all the required documentation so that it can move forward and not be delayed because it is sent back. We are now also involving the Fire Marshal in the permit process. The Board of Trustee only get cases that are in the Historical Residential, Historical Commercial, and Historic General zones. Ms. Bush and Mr. Padilla are working together on timelines. Once the trustees and Planning and Zoning become familiar with ordinances, we can accommodate the residents in a timely manner. Town ordinances and codes are available on the town website, mesillanm.gov.
