1 2 3 4 5	Trustee Garcia: first time case came forward Mayor Barraza, Mayor Pro Tem Johnson-Burick and herself were present. Motion made was to deny the appeal; Mayor Barraza and Mayor Pro Tem Johnson-Burick voted yes, she voted no. Second time it came forth to approve and it was denied. She wants to understand which one was right and which one was wrong.
6 7	Mr. Cervantes: there needs to be two-thirds majority. A motion is made to challenge PZHAC; three votes were needed to reverse.
8 9 10	Trustee Garcia: asked if they need to give a reason on why we voted the way we did and does there need to be a resolution.
11 12 13 14 15	Mr. Cervantes: trustees are not required to explain the vote but can as a courtesy. The more information given helps defend the board's action in court. There is a resolution required for other reasons, variances and special uses. The ordinance is silent for permits.
16 17	Trustee Garcia: asked what the timeframe is to file with District Court.
18 19 20	Mr. Cervantes: 30 days. The town currently has a case that did not meet the 30 days; Judge Duran felt the applicant did not receive adequate notice, so the appeal is being allowed to proceed.
21 22	Trustee Garcia: the letter was sent 30 days after the decision.
 23 24 25	Mr. Cervantes: 30 days upon receipt of the notice. No judge will throw out an appeal with regards to the notice.
26 27	Trustee Merrick: understands the town wants to stay out of court. The process to bring something back to the agenda is that there needs to be two trustees making the request.
28 29 30	Mr. Cervantes: he cannot answer that; follow the ordinance at all times.
31 32	Trustee Merrick: she is looking at the best course of action.
33 34 35	Mr. Cervantes: recommends allowing the applicant to file an appeal or waiving the one year waiting period to submit application.
36 37	Trustee Merrick: asked what the process is.
38 39 40	Mr. Cervantes: there needs to be a motion. The board's action would be to hold a worksession, give Public Notice while following the Open Meetings Act, taking a conservative approach.
41 42	Mayor Barraza: she understands that the ordinance states that the board of trustee's decision if final and conclusive.
43 44 45	Mr. Cervantes: that is correct, but the applicant may file again.

She would like to place it on the May 23 rd agenda with a Public Hearing prior to voting on the item that evening. She attended the Colonia board meeting who stated they are happy to see Mesilla has applied for funding. A GRT report has been provided.
20 21 22 23	Fire Chief Hoban stated he did not see staff reports on the agenda. New Mexico is suffering during this fire season. The Bosque just west of Mesilla had 45 acres burn. He will be presenting proposed restrictions at the next meeting and providing proper information.

27 28 29	Trustee Cadena asked that there be something in writing describing the process for putting something on the agenda.

44 45 46	Mayor Barraza responded she is happy to sit with her. She is concerned as well that there are discrepancies on what was provided to the trustees.
47 48	Trustee Merrick thanked Mayor Barraza and Ms. Sellers for attending Experience Mesilla meeting. Cinco de Mayo Fiesta was a good event.

4	Mayor Barraza asked the board to contact her with concerns or questions. Many times, she can address their

6	followed the process regarding Mr. Lucero. She took Trustee Cadena's question of why did the PZHAC
7	chairperson vote to Mr. Cervantes. He stated that the PZHAC is an appointed commission not an elected
8	position, so all commissioners do vote. This case was during the time we were short staffed and attempted to
9	meet all the deadlines. Believes she did follow the process. Cinco de Mayo went very well even though there
10	were a lot of activities going on. Thanked everyone for working together.
