a) Presentation: Fiscal Year 2022-2023 Budget

Ms. Bush reviewed the proposed budget by department and line item. The budget must be submitted to the state by 12:00 a.m. on Tuesday, May 31st.

Trustee Merrick asked if the budget includes people we need to hire.

Ms. Bush responded yes.

Mayor Barraza stated she calculated pay according to date when an increase will go into effect.

Trustee Merrick stated stipends are not included in the totals.

Mayor Barraza stated those will be reviewed and corrected.

Trustee Garcia asked about the vacant position listed as Accounts Payable; isn't Ms. Maya Accounts Payable.

Mayor Barraza responded that position has been kept in the budget just in case there is a need to hire someone. Ms. Bush has indicated there is a need for an Admin Assistant and/or file clerk. That will be listed as a vacancy.

Ms. Bush responded there is a need for a file clerk who will be helping all the departments.

Trustee Garcia asked about a stipend for Mr. Rodriguez.

Mayor Barraza stated she would like to look at the salaries for our Public Works employees. The Dona Ana County summer interns will be making more than our Public Work employees.

Mayor Pro Tem Johnson-Burick stated those interns are paid through grant funding which allows them to be paid \$15.00 an hour. Last year the person overseeing the program was making \$50.00 an hour.

Mayor Barraza stated they are looking at putting \$800,000.00 into operating expenses.

Mayor Pro Tem Johnson-Burick asked if there are any funds that can be used for the reserve.

Mayor Barraza responded that would be carryover money. Once current fiscal year is closed, we will know how much will be put into the reserve fund.

Ms. Bush reviewed the accounts, reserve, and investments.

Mayor Pro Tem Johnson-Burick stated she feels comfortable with the 5% COLA, the fact that we are being cautious. She asked if they had allocated the \$10,000.00 for the film project.

Mayor Barraza responded no; we are currently working on operating expenses. We will look at budget adjustments once the preliminary budget is submitted to the state.
