Mayor Barraza stated expenses are paid upfront through the General Fund and once paperwork is submitted, we are reimbursed.

Mr. Fuentes stated he would like a copy of what she is looking at so he can see the numbers.

Mayor Barraza stated those are questions that can be answered at the worksession so everyone is on the same page. Asked the board to submit questions, in writing, to Ms. Maya and Mr. Fuentes

Trustee Cadena stated she understands this is done to correct the line items.

Mr. Fuentes explained the process and why the BARs are needed at the end of the fiscal year.

Mayor Barraza stated cash balance is what is in the bank.

Trustee Cadena stated the budget is being padded, actuals are less than what is being budgeted. We just want to know where the money is being spent.

e) Discussion - LCPS MOA

Mayor Barraza stated LCPS is proposing eliminating the .75 SRO. It will be taken to the LCPS board on September 6, 2023 at 6:00 p.m. The one SRO will be split between Zia Middle School and Rio Grande Prep.

Marshal Salas stated the district feels there is only a need for one (1) SRO.

Mayor Barraza stated the MOA does reflect the dollar amount submitted for the 1.75 SRO but since they are only approving one (1) SRO we cannot pay the other officer out of those monies.

Mayor Barraza stated the board will need to see if the .75 SRO will be paid by the General Fund.

Trustee Garcia asked how much is needed for the .75.

Mayor Barraza responded around \$45,000.

Trustee Johnson-Burick stated we also need to look at safety.

Mayor Barraza stated we cannot put the officer at the school.

Marshal Salas stated the school board is trying to eliminate SROs at the schools. Currently there are security guards at the schools.

Mayor Pro Tem Merrick asked if the officers will still need to response to the calls.

Marshal Salas responded yes.

Mayor Barraza stated it will be discussed at their meeting on September 5th and vote at their September 19th meeting. It would be helpful for trustees and parents to attend the meetings and to contact their board.

Trustee Garcia stated she does not want to lose any deputies.

Mayor Barraza responded that will not happen. The approved vacant position has not been filled; the deputy would fill that position. The MOA will be brought forth.

Trustee Cadena asked if it is based on the new program.

Marshal Salas responded it is not based on the new program.

f) Discussion – El Paso Electric Grant Request

Mayor Barraza stated this year the town did not receive funding for the Summer Recreation program. The board will need to decide if they would like to continue the program.

Trustee Johnson-Burick asked what the grant amount is.

Mayor Barraza responded it is \$5,000.

Trustee Johnson-Burick stated the town can come up with the money to keep this program moving forward.

Mayor Pro Tem Merrick stated we can seek donations.

Mayor Barraza stated this is more to pay the salaries as the town does have funds to pay for supplies.

Trustee Garcia stated we can bring this to the businesses as well.

Mayor Barraza stated businesses are always willing to help.

Marshal Salas stated he is glad the trustees are stepping up to keep the Summer Recreation Program; this is a great program for the kids.

Trustee Cadena stated the Taylor Celebration does so much for the town; it deserves that recognition. She asked how the fiesta is coming along.

Trustee Garcia stated she was not told that the Architectural Styles Committee had been done away with. She understands there is a review committee; asked who is on that committee.

Mayor Barraza stated a sticker will be on the water bills asking residents to do their part to help control the mosquito issues. The Review Committee members are Mr. Salazar, Mr. Maese, PZHAC Chairperson. Trustees need to do their homework prior to the meeting. Bring any questions to Mr. Salazar prior to the meetings. We cannot continue to delay cases. There is no state statute that says packets need to be online. We are not hiding anything so we will put packets online for more transparency. A resident called NM Foundation for Open Government who in turn contacted the town regarding the minutes. Mayor read the NM Foundation for Open Government flyer. The minutes will be online by Wednesday or Thursday. We will be attending the NMML Conference this week.
