a. <u>PZHAC CASE#061643</u> – 2215 Calle de Guadalupe, submitted by John & Souheir Rawlings, requesting approval to replace door on north side of property with a window. Zone: Historical Residential (HR).

Mr. Salazar - This case was on our workshop and should be tabled as applicant will need to reapply with new set of plans.

b. PZHAC CASE #061717 – 2270 Calle de Principal, submitted by Basilica of San Albino, requesting approval to construct a storage structure on property. Zone: Historical Commercial (HC).

Mr. Salazar – this request was tabled last time we met do to the question of all new construction needed to meet the 7 ft setback and not the 3 ft, firewall setback. It was determined that the plans for the 3ft setback and firewall in place does meet code according to 18.35.060.

Commissioner Walkinshaw – asked about which door would be used to get inside the proposed storage structure. He understood, after it was explained the door to enter would be on the south side of the building furthest from Calle Principal.

What about the drainage, where is it going to go?

Mr. Maese (CID) – all the flow will be coming to the front in landscape irrigation. Because it is storage only, it does not require a drainage plan.

Commissioner Salas – I believe it has a French drain, to retain/collect into the landscape area.

### ITEM 7. COMMISSIONER/STAFF COMMENTS

Mr. Salazar

Explained the reason why packets were sent out earlier in the week for commissioner to review. Asked for help to contact him whenever there are questions or concerns with the cases in advance and not wait till the day of to bring them up. Resolving all questions and concerns before the meeting will avoid tabling cases and having the applicant wait another 3 to 4 weeks to have his case approved.

Secondly, if the commission would consider approving cases with conditions. This again will avoid tabling cases unnecessarily. Example, business request is approved with the condition an approved floorplan must be submitted before a business license is obtained.

Commissioner Walkinshaw – in previous meetings has asked for a list of administrative approvals which is listed in our code. I have not seen it being included in our agenda.

Mr. Salazar – you will need to make that request to the mayor.

Madam Chair Lucero – it will have to go through proper channels with that.

Had some concerns about a Calle de Huertos, dust and weeds everywhere. Would like to submit a formal complaint, have attempted to call codes and not been able to do so.

Mr. Salazar – explained the process for reporting a violations. All calls needed to be filtered through our dispatch center. MVRDA will then dispatch a code officer to location. Your call will then be recorded with time and date.

Will forward your concern to the Marshall via email.

Commissioner Walkinshaw – showed concerned as well as he has also put in a comment about a trailer that is hooked up and appears to have someone living in it.

Mr. Salazar – send me an email so I can forward your concerns. Put it in writing. But again, the proper way is to call dispatch.
