### PUBLIC HEARING NOTICE – SUMMARY OF PROPOSED CODE AMENDMENTS

The Town of Mesilla Board of Trustees will conduct public hearings to consider amendments to various sections of the Mesilla Town Code concerning municipal governance, code enforcement, land use administration, public nuisances, building permit fees, and utility regulations. Proposed amendments include:

- **AMENDMENT TO MESILLA TOWN CODE (MTC 18.06 PLANNING AND ZONING HISTORICAL APPROPRIATENESS COMMISSION) RESTRUCTURING OF TERMS AND CONSIDERATION TO PAY.**
- **AMENDMENT/ADOPTION OF HEARING EXAMINER ORDINANCE AUTHORITY AND RESPONSIBILITIES. DEFINE A PROCESS TO ENFORCE MUNICIPAL CODE.**
- **AMENDMENT TO MESILLA TOWN CODE (MTC 8.15 NUISANCES) – CONSIDERATION IN REGULATING NOISE NUISANCE FOR THE BEST INTEREST TO OUR RESIDENTIAL AND COMMERCIAL ZONES.**
- **AMENDMENT TO MESILLA TOWN CODE (MTC 15.15 BUILDING CODE) CONSIDER AMENDMENTS TO THE TOWN'S FEE SCHEDULE/OR ORDINANCES REGARDING PERMIT FEES, INCLUDING WHETHER GOVERNMENTAL ENTITIES, SUCH AS SCHOOL DISTRICTS AND NON-PROFITS, SHOULD BE EXEMPT FROM CERTAIN PERMIT FEES.**
- **REVIEW MESILLA TOWN CODE (MTC 13.10 UTILITIES, GENERAL PROVISIONS) TO CONSIDER AMENDMENTS TO REGARDING THE REVIEW, ESTABLISHMENTS AND ADJUSTMENT OF UTILITY FEES AND CHARGES.**
